

## Core-based statistical areas for ASCs

Prior to 2008, geographic payment differences for ambulatory surgical centers (ASCs) were based on metropolitan statistical areas (MSAs). Beginning January 1, 2008, MSAs were replaced by CBSAs; you'll need to know yours before you can select the correct list of fees.

You can determine the CBSA in which your facility is located by using the county/CBSA crosswalk below.
