

Core-based statistical areas (CBSAs)

Prior to 2008, geographic payment differences were based on Metropolitan Statistical Areas (MSAs). Beginning January 1, 2008, MSAs are replaced by CBSAs; you'll need to know yours before you can select the correct list of fees.

You can determine the CBSA in which your facility is located by using this Municipality/CBSA crosswalk:
