

Important Information Regarding Medicare Payment Allowance for Injectable Drugs

Providers who bill Florida Medicare for injectable drugs should be aware of updated payment allowances so they may adjust their fees accordingly:

These allowances are effective for services rendered on or after January 1, 2001 that are *processed on or after October 1, 2001*.

Please remember that assignment must be accepted for these services, as mandated by the Benefits Improvement and Protection Act of 2000 (BIPA).

Pneumococcal Pneumonia, Hepatitis B, and Influenza Virus Vaccines

Information concerning billing for pneumococcal pneumonia, hepatitis B, and influenza virus vaccines was published in the 4th Quarter 2001 *Medicare B Update!* (pages 6-8). *CPT* codes 90740 and 90743 (that are new for 2001) were inadvertently omitted from the list of codes provided in that article.

This Special Issue *Update!* provides updated payment allowances for influenza virus vaccine *CPT* codes 90657, 90658, and 90659, effective for services rendered on or after January 1, 2001, processed on or after October 1, 2001.
