

Medicare Secondary Payer (MSP)


The purpose of the MSP Interactive Billing Tool is to assist you in deciding if Medicare is the primary or secondary payer for certain types of MSP.

This tool will enable you to bill the correct insurer the first time; saving you time and money.





If payment is denied or no response is received from insurer, bill Medicare conditionally.




Bill Department of Labor (DOL). If payment is in full, no Medicare payment can be made. If DOL denies some/all services, bill Medicare conditionally.




Disability insurance is primary. If insurer pays, bill Medicare secondary.


